## **URGENT: DRUG PRODUCT RECALL**

**RE: (Alveda Pharmaceuticals Inc.) Acetylcysteine Inj. 200 mg/ml, 30 ml, DIN 02300435, Lot 175080, 175081, and 175082, Expiry Date October 2020**

On Friday, April 24, 2020, Teligent Canada Inc. initiated a voluntary recall of Alveda Pharmaceuticals Inc.'s **Acetylcysteine Inj. 200 mg/ml, 30 ml, DIN 02300435, Lot 175080, 175081, and 175082** with the **Expiry Date of October 2020** from the Canadian market.

The recall was initiated due to: **The incorrect barcode on vials of Alveda labelled Acetylcysteine Inj. 200 mg/ml (6g/30ml) DIN 02300435.** The barcode in the QR Code on the vial label is "837641000522". Barcode "837641000522" correlates to the carton UPC code of Teligent Diazepam Injection USP 5 mg/ml (10 mg/2ml) ampoules, 10 pack, DIN 02385392. Please note the carton label barcode for Acetylcysteine Inj. 200 mg/ml (6g/30ml) DIN 02300435 is correctly written as "837641000263".

The risk classification associated with this product is **Type III**, a situation in which the **use of, or exposure to, a product is not likely to cause any adverse health consequences.** There are no adverse reaction reports associated with the incorrect barcode on the vial label.

**The depth of this recall extends to healthcare establishments.**

Due to this recall, customers have been requested to:

- Stop all sale or distribution of Acetylcysteine Inj. 200 mg/ml, 30 ml, DIN 02300435 lot number(s) 175080, 175081, and 175082
- Conduct an inventory assessment.
- Notify your point of purchase of the quantity of inventory in your possession of each batch
- Return recalled product to your point of purchase.

The above steps should be completed by **Thursday, May 7<sup>th</sup>, 2020.** Health Canada has been notified of this recall.
